PSAT/NMSQT stands for Preliminary SAT/National Merit Scholarship Qualifying Test. It is a standardized test that provides firsthand practice for the SAT Reasoning Test™. It also provides a chance to enter the National Merit Scholarship Corporation (NMSC) scholarship programs.*

**To potentially qualify for the National Merit Scholarship Program, students must score within the top 1/2 of the top 1% of all students in the nation. Sophomores cannot qualify for the National Merit Scholarship Program.*

This test is a *co-sponsored* program by the College Board and National Merit Scholarship Corporation (NMSC).

The PSAT/NMSQT measures:

- * Critical reading skills.
- * Math problem-solving skills.
- * Writing skills.

Benefits to Students:

- * The PSAT/NMSQT provides entry into the National Merit Scholarship Program (**Juniors Only**).
- * If qualified, it connects students to millions of potential scholarship dollars through the program.
- * Assesses their mastery of the skills necessary for college-level work.
- * Offers free, personalized practice for the SAT through Khan Academy based on test results.
